#### Howard County: Overdose Update

As of February 25, Howard County Police reported 34 known overdoses so far in 2019: **4\* Fatal and 30 Non-Fatal = 34 Total Overdoses** 

\*In fatal cases, some deaths are pending autopsy results for opioids and/or other substances. Numbers may fluctuate. If you or someone you know in Howard County needs help with an opioid or other drug issue, call 800-422-0009, 24-hours a day, or go to Grassroots Crisis Intervention Center for screening & referral assistance. Grassroots is located at 6700 Freetown Road in Columbia.

Naloxone (also known by brand name Narcan) is a life-saving medication that can be used to help restore breathing to someone who has overdosed on opioids, including heroin, prescription pain medication, and fentanyl. ### Next Drive-Thru Medication & Sharps Collection: Saturday, April 27

The next convenient drive-thru medication and sharps (needles, syringes and EpiPens) collection will be on Saturday, April 27 from 10 a.m. to 2 p.m. in the Wilde Lake Village Center parking lot in Columbia. HC DrugFree's team will take your unwanted and expired over-the-counter and prescription medication as well as any sharps. No need to remove medication or labels from the bottles and no need to get out of your vehicle.

Medications are guarded and transported by the Howard County Police Department and the Drug Enforcement Administration (DEA). Community service hours available for student volunteers. Safe storage: Keep friends and family from having easy access to your medication and don't unknowingly be their drug dealer. Secure your medication in a locked closet, locked filing cabinet, safe, etc. If you have no safe way to store your medication, HC DrugFree has a free medication storage box waiting for you or your family.
